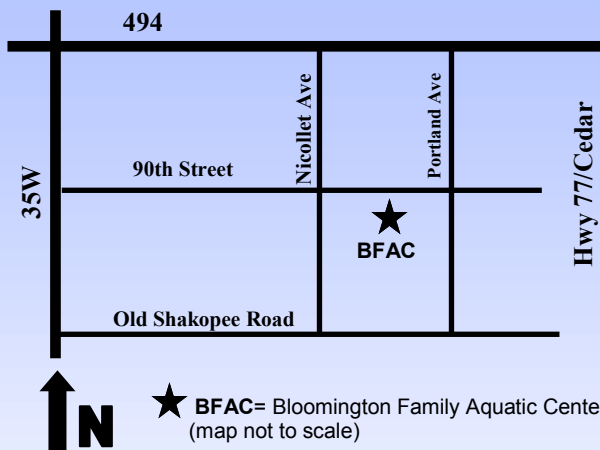
RESERVATION POLICIES, PROCEDURES AND DIRECTIONS

Come and enjoy a summer at the Bloomington Family Aquatic Center! Experience our zero-depth entry, tot-slide play feature, tumble buckets, jet spray, diving boards, drop slide, and the thrilling, looping waterslides.
If you get hungry, the concession stand is available.

Reservation Policies and Procedures

- Reservations need to be made at least 2 weeks prior to the date of the reservation to receive the special group rate.
- Reservations can be made by submitting a completed Reservation Form and \$100 deposit to the Bloomington Parks and Recreation Office (952-563-8877).
- Reservations are for patrons that are ages 6 years and above only.
- Pool entrance fee is an admission fee; therefore, all children and chaperones must be accounted for in the fee even if they are not swimming.
- All groups need to agree and sign the Group Etiquette and Rules Form for the BFAC.
- If you are tax exempt, please send a copy of your certificate of exemption for the City of Bloomington to keep on file with your reservation form. We must have a copy of the certificate on file prior to your reservation in order to avoid being charged tax.

BIRTHDAY PARTIES AND GROUP RESERVATIONS



- Includes your own poolside gazebo to enjoy your party.
- Birthday cakes may be brought in, but must be eaten in our designated picnic area.
- Concession treats are also available for purchase.
- Payment may accompany reservation form if the number of participants is known when making your group reservation **OR**
- Fees may be paid on the day of your reservation at the pool with Cash, Visa, MasterCard, American Express or Discover. \$100 deposit is required with reservation. **NO CHECKS WILL BE ACCEPTED AT THE POOL.**
- **NO REFUNDS** can be given after purchase.
- Cancellations must be made prior to 11:00 a.m. on the day of your scheduled reservation in order to avoid being charged. Please call P & R at 952-563-8877 to make a cancellation of a group pool reservation.

During regular business hours

- Payment may accompany the reservation form if the number of participants is known when making your group reservation. **OR**
- Fees can be paid on the day of your reservation at the pool with Cash, Visa, MasterCard, American Express or Discover. \$100 deposit is required with reservation **NO CHECKS WILL BE ACCEPTED AT THE POOL.**
- Organizations may be billed for their group with prior approval from the Bloomington Parks and Recreation Office.
- Minimum of 20 participants is required for discounted rate.
- Wristbands will be handed out at the pool the day of your reservation. Please affix these to participants prior to admission.
- **NO REFUNDS** can be given after purchase.
- If you plan on visiting our concessions area as a group, please sign up at the front desk for a concession time slot.
- Cancellations must be made prior to 11:00 a.m. on the day of your scheduled reservation in order to avoid being billed/charged. Please call P & R at 952-563-8877 to make a cancellation of a group pool reservation.

After business hours

- Payment must accompany reservation form – Reservation will not be taken without payment.
- Diving boards and slides may not be operational at the same time. They will be on a rotation.
- Cancellations must be made at least 48 hours in advanced to receive refund minus \$50 cancellation fee. Cancellations due to severe weather the day of the event will receive a full refund.
- Concessions service may be limited – Pre-ordered food packages are available by request .

TO ENSURE YOUR VISIT IS BOTH SAFE AND ENJOYABLE, PLEASE FOLLOW THE RULES BELOW:

All swimmers must have a swimsuit in order to swim in the pool.

- This includes an appropriate top and bottom for females and appropriate swim trunks for males.
- Swim Diapers are required for children that are not potty-trained.
- Concessions are available for purchase inside the facility.
- Picnic space is available inside and outside of the pool fence.

THE FOLLOWING ARE NOT ALLOWED:

- Tobacco and Alcohol use
- Snorkels, Fins and Balls
- Inflated articles and floatation equipment EXCEPT for U.S. Coast Guard Type I-III approved floatation devices, with an adult 18 years of age or older within arms reach at all times.
- Horseplay and Running.
- Diving off pool sides
- Open cuts or communicable diseases
- Glass containers inside the facility
- Animals

WATER SLIDE RULES:

- Walk up the stairs
- One person at a time in each flume
- Hands and feet must be kept inside
- No diving at the end of the slide
- No standing, kneeling, rotating or stopping
- Use the ladder closest to the slide
- Follow all the instructions of the attendants
- Adults may catch their children in the water at the bottom of the slide

DIVING WELL RULES:

- Exit the diving well promptly
- One bounce on the board
- One person on the board at a time
- One person on the ladder at a time
- Swim to the closest ladder after diving off the boards
- Walking down any ladder is prohibited
